

OFFICIAL RULES: Sapulpa Park Friends Splash Pad Sweepstakes

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID WHERE PROHIBITED.

THE PROMOTION (defined below) IS SUBJECT TO THESE OFFICIAL RULES AND BY ENTERING, EACH ENTRANT UNCONDITIONALLY AGREES TO BE BOUND BY THEM.

1. Eligibility

The Sapulpa Park Friends Foundation Splash Pad Sweepstakes promotion (the "Promotion") is open only to legal residents of the State of Oklahoma who are at least thirteen (18) years of age at the time of entry. Void where prohibited by law. Officers and employees of the Sapulpa Park Friends Foundation, D-Luxe Properties, LLC, D-Luxe Dispensary, their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children), and household members (people who share the same residence at least three (3) months out of the year whether related or not) are not eligible. Further, the owners, officers and employees of a specific Retailer (as defined below), their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children), and household members (people who share the same residence at least three (3) months out of the year whether related or not) are not eligible to receive a Ticket (as defined below) from their related Retailer, but may receive Ticket(s) from other participating and unrelated Retailers. The Promotion is subject to all applicable federal, state, and local laws and regulations. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion. Winning a Prize is contingent upon fulfilling all requirements set forth herein.

BY ENTERING, YOU REPRESENT THAT YOU ARE AT LEAST EIGHTEEN (18) YEARS OF AGE AT TIME OF ENTRY AND HAVE A VALID DRIVER'S LICENSE IN THE STATE OF OKLAHOMA (each such individual an "Entrant").

2. Sponsor and Administrator

Sponsor and Administrator: Sapulpa Park Friends Foundation, 515 East Dewey Avenue, Sapulpa, Oklahoma 74066 ("Sponsor").

3. Timing

The Promotion begins on or about 8:00 A.M. Central Time ("CT") on April 5, 2022 and ends on or about 6:00 A.M. CT on April 23, 2022. (the "Promotion Period"). Sponsor's computer is the official time keeping device for this Promotion.

4. How to Enter

To enter, Entrants must visit the physical, retail location of one of the various participating business sponsors of the Event (collectively, the "Retailers") during the Promotion Period and pick-up a ticket (each a "Ticket"). Limit of one Ticket per person per Retailer per day during the Promotion Period. Entrants will take one half of the Ticket with them to bring to the Event while the other half of the Ticket will be retained by the Retailers (the "Entry Ticket(s)"). On the day of the Event, the Retailers will bring the Entry Tickets to be placed in the drawing for the Grand Prize. As noted in paragraph 1 above, an Entrant is not permitted to receive a Entry Ticket from a related Retailer.

Personally-identifying information of Entrants shall be used by Sponsor only with respect to this Promotion, and shall be destroyed after the end of the Promotion and the acceptance of the Grand Prize except to the extent Sponsor is required by law to maintain and/or disclose such information. By entering, each participant, Entrant, and the Grand Prize Winner acknowledges and agrees that personally-identifying information may be shared with third party service providers to assist in the fulfillment of the Promotion.

ENTRANTS ACKNOWLEDGE AND AGREE THAT THEY WILL NOT SUBMIT IN ANY FORM OR MANNER ANY PERSONALLY IDENTIFIABLE INFORMATION OF A MINOR CHILD YOUNGER THAN 13 YEARS OF AGE AT THE TIME OF ENTRY ("Prohibited Personally Identifying Information"). SPONSOR DOES NOT SEEK TO USE, DISSEMINATE OR COLLECT PROHIBITED PERSONALLY IDENTIFIABLE INFORMATION THROUGH THE PROMOTION, AND ANY ENTRY THAT INCLUDES PROHIBITED PERSONALLY IDENTIFIABLE INFORMATION IS SUBJECT TO DISQUALIFICATION AND DESTRUCTION SHOULD SPONSOR OBTAIN ACTUAL KNOWLEDGE THAT SAID ENTRY INCLUDES PROHIBITED PERSONALLY IDENTIFIABLE INFORMATION.

Prohibited Personally Identifying Information includes the following information of an individual under 13 years of age: first and last names; home or physical addresses, including street name and city or town name; online contact information, such as email address or anything that permits direct contact with a person online; screen or user names; telephone numbers; social security numbers; photograph, video, or audio file that contains child's image or voice; or geolocation information able to identify street name or city or town name.

Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected ticket entries/registrations, which will be disqualified, including, without limitation, Retailers' failure to bring an Entry Ticket to the Event. Potential winner will be required to show proof of a valid Oklahoma Driver's license to be eligible for the Grand Prize. All entries become the sole and exclusive property of Sponsor and will not be returned.

5. Winners Selection

Prize Drawing: There is one (1) potential prize set forth in detail below (referred to as a "Prize" or "Grand Prize") and one (1) potential Grand Prize Winner (as defined below).

On or about 7:00 P.M. CT on April 23, 2022 at the D-Luxe Food Truck Park located at 923 South Main Street (the "Event"), all Entry Tickets provided by Retailers will be entered into a drawing for the Grand Prize and one (1) potential winner will be randomly selected from all eligible entries received during the Promotion Period. The entry drawn will be eligible for the Grand Prize, as detailed below, and the Entrant of such entry will be announced at the Event. This potential winner is required to attend the Event and must make such presence known to Sponsor within ten (10) minutes of such announcement at the Event (the "Response Period"). Sponsor shall have no liability if a potential winner is not in attendance or does not hear the announcement for any reason and thus does not respond within the Response Period. The Grand Prize Winner shall also be required to complete an Affidavit of Eligibility and Liability/Publicity Release, which must be completed and executed at the Event. If, despite reasonable efforts, a potential winner does not respond within the Response Period or refuses to execute the Affidavit of Eligibility and Liability/Publicity Release, such potential winner will forfeit the Grand Prize, at Sponsor's sole discretion, and an alternate winner may be randomly selected by Sponsor. If any potential winner is found to be ineligible, or if he or she has not complied with or does not agree with these Official Rules or declines the Grand Prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may (at Sponsor's sole discretion) be selected. Sponsor may successively attempt to contact up to two (2) potential winners of the Grand Prize in accordance with such procedure, and if there is still no confirmed Grand Prize Winner of the Grand Prize in question after such attempts have been made, the Grand Prize may go unawarded. Sponsor may, at its sole discretion, randomly select additional entries should additional entries be required to award the Grand Prize. The foregoing process is the "Prize Selection Process." Upon verification by Sponsor that the Entrant/potential prize winner announced by Sponsor as a potential winner pursuant to the Prize Selection Process is eligible to win in accordance with these Official Rules, and upon agreement by the potential winner of these Official Rules and acceptance of the Grand Prize, the Entrant/potential winner will be the "Grand Prize Winner".

6. Prize

ONE (1) GRAND PRIZE is available consisting solely of: One (1) new **2022 CORVETTE C8** with a Total Actual Retail Value ("ARV") of **\$90,000.00 USD**.

No cash equivalent for the Grand Prize will be given. The Grand Prize consists only of the elements expressly set forth above, including tag, title, and excise taxes. Any other expense, fee, and/or incidental costs not expressly stated in the Grand Prize description above shall not be included in the Grand Prize. Unless otherwise expressly stated herein, the Grand Prize does not include travel, lodging, food or other expenses not expressly stated in these rules and is exclusive of all income taxes and other taxes not expressly included above, for all of which the Grand Prize Winner is solely responsible. The Grand Prize is non-transferable, and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the listed Grand Prize for one of equal or greater value for any reason. The Grand Prize Winner is responsible for all taxes and fees associated with the Grand Prize receipt and/or use. Actual retail value of the Grand Prize may vary, and the Grand Prize Winner will not receive the difference between actual and approximate retail value. The Grand Prize must be redeemed at

the Event. Odds of winning depend on the number of eligible entries received during the Promotion Period.

ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR AND SPONSOR'S DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE PROMOTION. WINNING THE GRAND PRIZE IS CONDITIONED ON ACCEPTANCE OF THESE OFFICIAL RULES.

7. Entry Conditions and Release

By entering, each participant, Entrant and the Grand Prize Winner agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Promotion; (b) release and hold harmless the Sponsor and each of their respective officers, employees, and beneficiaries, including the City of Sapulpa, D-Luxe Dispensary, D-Luxe Properties, LLC, the Retailers, and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Promotion or the websites and online forms used in connection with the Promotion, including, without limitation, the Retailers, and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Promotion, acceptance or use or misuse of the Grand Prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an Entrant's participation in the Promotion and/or Entrant's acceptance, use or misuse of the Grand Prize.

8. Publicity

Except where prohibited by law, acceptance of the Grand Prize constitutes the Grand Prize Winner's consent to Sponsor's and its agents' use of the Grand Prize Winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration. **IF ENTRANT IS CHOSEN AS THE GRAND PRIZE WINNER, ENTRANT'S PERSONAL IDENTIFYING INFORMATION MAY BE DISCLOSED TO THIRD PARTIES INCLUDING, WITHOUT LIMITATION, PLACING ENTRANT'S NAME ON A PRIZE WINNERS LIST AS REQUIRED BY STATE LAW, IF APPLICABLE.**

9. General Conditions

Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, (a) for any reason or no reason one (1) day prior to the Event, or (b) the day of the Event in the event

of fraud, technical failures, law or legal process, or a factor beyond Sponsor's reasonable control, as determined by Sponsor in its sole discretion. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. Limitations of Liability

Every Entrant and the Grand Prize Winner participates in the Promotion and uses and/or accepts the Grand Prize at their own risk. The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to, malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; and/or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Entrant's participation in the Promotion or receipt or use or misuse of the Grand Prize. THE GRAND PRIZE WINNER TAKES THE GRAND PRIZE "AS-IS" WITH ANY AND ALL FAULTS AND WITHOUT WARRANTY. THE GRAND PRIZE WINNER ACKNOWLEDGES AND AGREES THAT NEITHER THE RELEASED PARTIES NOR ANY OF THEIR OWNERS, EMPLOYEES, AGENTS, SUCCESSORS, OR ASSIGNS SHALL BE LIABLE TO THE GRAND PRIZE WINNER OR ANY OTHER PERSON OR ENTITY FOR USE OR MISUSE OF THE GRAND PRIZE, WHETHER BY THE GRAND PRIZE WINNER OR OTHERWISE.

Entrants, the Grand Prize Winner and any other individual or entity participating in the Promotion agree that any and all claims, judgments and awards resulting and/or arising from the Grand Prize, the Promotion, or entry therein shall be limited to actual out-of-pocket costs directly related to entry into the Promotion, and in no event shall include attorneys' fees, and under no circumstances will any Entrant, the Grand Prize Winner, individual or entity be permitted to obtain awards for damages other than for actual out-of-pocket expenses directly related to entry into the Promotion and each such Entrant, the Grand Prize Winner, individual and/or entity hereby waives all rights to claim any damages other than actual out-of-pocket expenses directly related to entry into the Promotion, including, without limitation, punitive, incidental and consequential damages and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** No more than the single Grand Prize will be awarded. 11. Disputes

Any and all disputes, claims and causes of action arising out of or connected with this Promotion, or the Grand Prize awarded shall be resolved individually, without resort to any form of class action, and any and all disputes, claims and causes of action arising out of or connected with this Promotion, or the Grand Prize awarded, shall be resolved exclusively by the state District Court of Creek County, Oklahoma. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Entrant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of Oklahoma, without giving effect to any choice of law or conflict of law rules (whether of the State of Oklahoma or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Oklahoma.
